	Global Securities sub-accounts are not applicable to all corporate and institutional investors, clients affiliated with Account Executive (AE).				
2.	「環球密密Trade子賬戶」的資產不受SIPC保障。致富向「環球密密Trade子賬戶」提供財務通融以利便取得在證券市場上市的				
	證券及(如適用)繼續持有該等證券。該等財務通融可能會限制客戶行使證券的投票權利。「環球密密Trade子賬戶」的美股交				
	收費較「環球股票主賬戶」為低,客戶可自行考量申請「環球密密Trade子賬戶」與否。				
3.	The assets of "Global Securities Frequent Trade sub-account" are not protected by SIPC.
