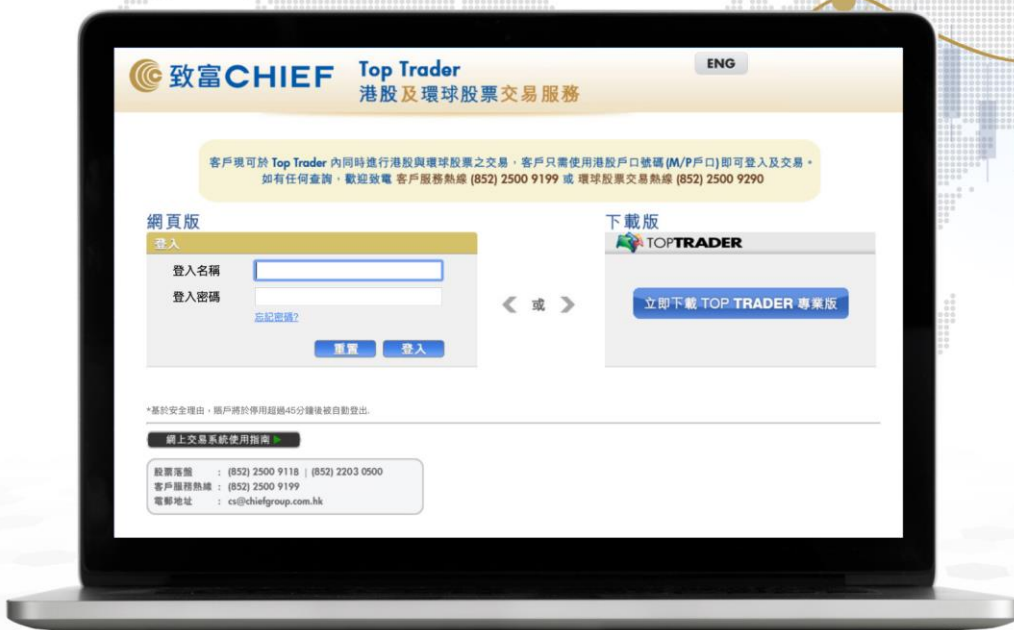
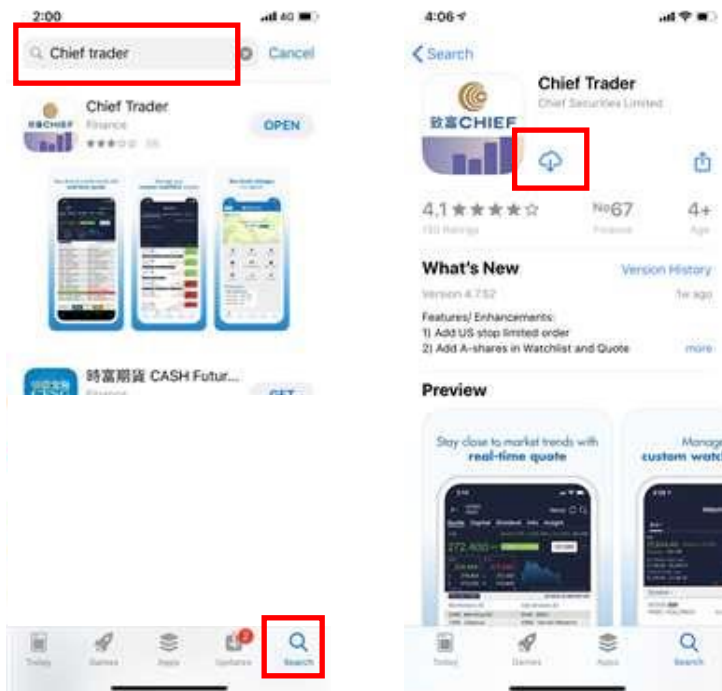


# TOP Trader Web Version Two-Factor Authentication User Manual

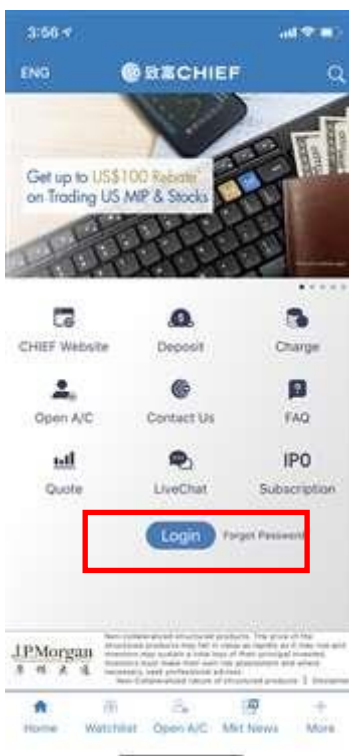


## How to download "Chief Trader" Mobile APP



1. Open App Store/ Google Play Store on your device
2. Click "Search" and enter "Chief Trader", tap on the APP icon
3. Tap "Install" icon to download the APP

## First time registration and login flows



### "Lagon ID"

The account number provided when account opening, for example, "P/M 88888". It can be changed after your first login.

### "Password"

The first-time login password will be sent via system during account application. The password should contain 8 or more digits, with numerical and alphabetical characters, uppercase and lowercase

### "Mobile number"

Your registered mobile phone number when account opening for receiving SMS

Enter the above information, tap "Next" to complete the registration

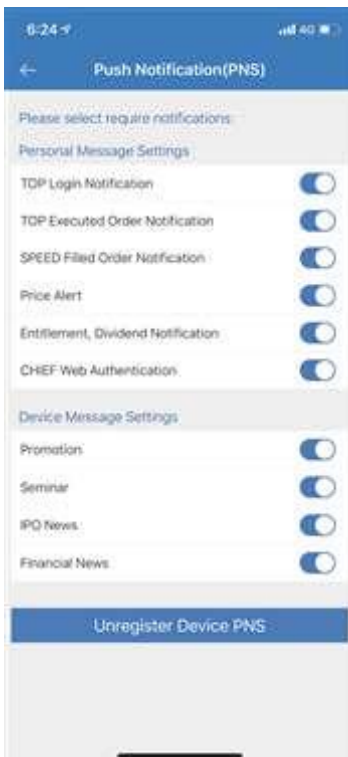
## How to use Chief Authentication System to login to Top Trader (Web version)

### 1. Login Top Trader (Web version) via Token



1. Complete download and registration on "Chief Trader" mobile APP
2. Open Top Trader (Web version) (Website: <https://www.chiefgroup.com.hk/en/account/download-software>) · enter Login ID and Password
3. Enter the one time 6-digit token received from "Chief Trader"\*

\*To receive the token, please turn on the "Push Notification (PNS)" service in the APP



## 2. Login Top Trader (Web version) via QR code



1. Complete download and registration on "Chief Trader" Mobile APP
2. Open Top Trader (Web version) (Website: <https://www.chiefgroup.com.hk/en/account/download-software>) · enter Login ID and Password
3. Scan the QR code at "Chief Web Authentication" at "Chief Trader"
4. Login successful
